Outcomes

Course Outcome(s):

Record and transcribe "live" dictation at a minimum skill level of 180 wpm.

Objective(s):

- 1. Write in a realtime session for five minutes with a goal of at least 95% accuracy.
- 2. Transcribe a minimum of 2 (two) 180 wpm Q&A tests for 5 minutes with at least a 95% accuracy rate.
- 3. Transcribe 1 (one) Jury Charge test at 160 wpm, and 1 (one) Literary test at 140 wpm, each test being 5 minutes in length and transcribed with at least 95% accuracy.

Course Outcome(s):

Transcribe a minimum of one literary realtime speed test at 120 wpm for 5 minutes at an accuracy rate of at least 95%.

Objective(s):

- 1. Write in a realtime session for five minutes with a goal of at least 95% accuracy.
- 2. Write a minimum of one literary realtime speed test at 120 wpm for 5 minutes at an accuracy rate of at least 95%.

Course Outcome(s):

Apply accurate writing techniques for numbers, alphabets, and acronyms with accuracy in the electronic support program.

Objective(s):

- 1. Demonstrate knowledge of steno or voicewriting techniques to expand vocabulary and write technical terms.
- 2. Apply body of accurate language art skills-spelling, proofing, grammar, editing, punctuation, and capitalization.
- 3. Write in a realtime session for five minutes with a goal of at least 95% accuracy.
- 4. Transcribe a minimum of 2 (two) 180 wpm Q&A tests for 5 minutes with at least a 95% accuracy rate.
- 5. Transcribe 1 (one) Jury Charge test at 160 wpm, and 1 (one) Literary test at 140 wpm, each test being 5 minutes in length and transcribed with at least 95% accuracy.
- 6. Write a minimum of one literary realtime speed test at 120 wpm for 5 minutes at an accuracy rate of at least 95%.

- 1. Demonstrate accurate steno or voicewriting skills by recording dictation from medical depositions, legal opinions, literacy writing, jury charge writing, Q&A writing, and motions.

- 3. Write in a realtime session for five minutes with a goal of at least 95% accuracy.
- 4. Transcribe a minimum of 2 (two) 180 wpm Q&A tests for 5 minutes with at least a 95% accuracy rate.
- 5. Write a minimum of one literary realtime speed test at 120 wpm for 5 minutes at an accuracy rate of at least 95%.

Course Outcome(s):

Demonstrate accuracy in realtime writing test situations.

Objective(s):

- 1. Take dictation for 5 minutes and transcribe material within 1 hour 15 minutes.
- 2. Write a minimum of one literary realtime speed test at 120 wpm for 5 minutes at an accuracy rate of at least 95%.

- a. Homework practice done within and outside of Realtime Coach
- b. Quizzes on technical vocabularies
- c. Speedbuilding tests with 96% accuracy goal
- d. Realtime writing tests with 96% accuracy goal
- e. Drills and exercises as evaluated by Realtime Coach at 96% accuracy
