- 3. Demonstrate the ability to work well with other allied health professionals and patients, demonstrating empathy and compassion.
- 4. Demonstrate knowledge of community resources and be able to create a coordination of care plan with preceptor.
- 5. Complete 105 hours of clinical experience as a patient navigator under the auspices of a preceptor.

 - b. Complete assessment form delineating tasks performed

 - a. Develop a portfolio of 10 local community resources to assist patients with social needs
 - b. Develop a portfolio of 10 local community resources to assist patient with medical support
