Course Outcome(s):

Integrate nursing concepts to provide safe, quality, evidence-based, patient-centered nursing care to diverse patients with acute unstable and chronic conditions.

Objective(s):

- a. Conduct a head-to-toe and/or focused physical, behavioral, psychological, and spiritual assessment of health and illness parameters in patients, using developmentally and culturally appropriate approaches.
- b. Manage patient needs based on assessment findings for the patient with acute unstable and chronic conditions.
- c. Formulate an individualized plan of care identifying evidence-based nursing appropriate for patients with acute unstable and chronic conditions.
- d. Integrate patient-centered care that reflects an understanding of human growth and development, pathophysiology, pharmacology, nutrition, medical management, and nursing management for patients with acute unstable and chronic conditions.
- e. Integrate factors that create a culture of safety for patients with acute unstable and chronic conditions.
- f. Construct, implement, and evaluate a patient teaching plan that reflects developmental stage, age, culture, spirituality, patient preferences, and health literacy considerations.
- g. Measure patient outcomes to evaluate the effectiveness and impact of nursing care.
- h. Deliver care within an expected timeframe for patients with acute unstable and chronic conditions.
- i. Utilize effective communication techniques when transitioning care to another interprofessional health care team member.
- j. Integrate cultural awareness and sensitivity concepts when providing care to diverse patients with acute unstable and chronic conditions.
- k. Propose ways to revise the plan of care based on an ongoing evaluation of patient outcomes including recognition of alterations to previous patient conditions.
- I. Demonstrate safe performance of basic psychomotor skills for efficient, safe, and compassionate patient care.
- m. Document all aspects of care for provided for patients with acute unstable and chronic conditions.

Integrate clinical judgment to make patient-centered care decisions for patients with acute unstable and chronic conditions.

Objective(s):

- a. Use clinical judgment to make management decisions to ensure accurate and safe nursing care, including addressing anticipated changes in the patient's condition with acute unstable and chronic conditions.
- b. Use clinical judgment when implementing all steps of the nursing process identifying the best available evidence.
- c. Anticipate common risks for patients with acute unstable and chronic conditions, and predict and manage potential complications.
- d. Manage and prioritize care for patients with acute unstable and chronic conditions.
- e. Assess the clinical microsystem and its impact on the nurse's ability to provide safe, quality care for patients with acute unstable and chronic conditions.

Course Outcome(s):

Integrate and evaluate a quality improvement process to improve patient care for patients with acute unstable and chronic conditions.

Essential Learning Outcome Mapping:

Critical/Creative Thinking: Analyze, evaluate, and synthesize information in order to consider problems/ideas and transform them in innovative or imaginative ways.

Objective(s):

- a. Utilize and evaluate quality improvement processes, including nursing-sensitive indicators in the microsystem of care when caring for patients with acute unstable and chronic conditions.
- b. Collect information about quality improvement projects used in the care of patients with acute and chronic conditions.
- c. Identify gaps between local and national standards of practices and competencies and how they affect patient care for patients with acute and chronic conditions.
- d. Identify possible errors and ways to prevent those errors for patients with acute unstable and chronic conditions.
- e. Implement National Patient Safety Goals in the care of patients with acute unstable and chronic conditions.

Course Outcome(s):

Contribute to collaboration and teamwork with members of the interprofessional team, the patient, and the patient's support systems for patients with acute unstable and chronic conditions.

Objective(s):

- a. Communicate effectively with all members of the interprofessional healthcare team, including the patient and the patient's support network when making decisions and planning care.
- b. Communicate data collected during the patient assessment to the appropriate interprofessional healthcare team member(s).
- c. Implement selected patient safety and quality improvement concepts within the context of the interprofessional team for patients with acute unstable and chronic conditions.
- d. Select conflict resolution principles as needed for patients with acute unstable and chronic conditions.

Utilize information management principles, techniques, and systems, and patient care technologies that are used to communicate, manage knowledge, mitigate error, and support decision-making for patients with acute unstable and chronic conditions.

Interpret planned patient care within the context of the American Nurses Association (ANA), Quality Safety Education for Nurses (QSEN), National League for Nurses (NLN), and National Association for Practical Nurse Education and Science (NAPNES) Standards of Practice for patients with acute unstable and chronic conditions.
- c. Demonstrate accountability for nursing care given by self and/or delegated to others as applied to the care of patients with acute unstable and chronic conditions.
- d. Integrate nursing management skills and knowledge of the rules and principles of delegation when working with other healthcare team members.
- e. Serve as a patient advocate for patients with acute unstable and chronic conditions.
- f. Review the impact of economic, political, social, and demographic forces on the delivery of health care to patients with acute unstable and chronic conditions.
