Course Outcome(s):

Apply interdisciplinary terminology, concepts, and findings to analyzing women's status in developing and developed countries.

Objective(s):

1. Compare and contrast United States data to women's status in other countries.
2. Utilize internet, print, and or/electronic resources to gather, organize and summarize information on women's status outside the United States.
3. Compare and contrast information on social, economic, religious, and political positions of women in a minimum of four regions of the world.
4. Summarize theoretical perspectives explaining the relative global inequality of women.
5. Identify research methodologies related to the field of transnational and global feminisms.
6. Identify agents of socialization and social control affecting women's life chances in global societies.
7. Discuss the interplay of social institutions shaping and maintaining gender roles.
8. Evaluate current policies and programs affecting women's lives transnationally, utilizing relevant information sources generated nationally and internationally.

Examine personal and cultural biases, prejudices, ethnocentric views, stereotypes, etc. through self-reflection and introspection.

Cultural Sensitivity: Demonstrate sensitivity to the beliefs, views, values, and practices of cultures within and beyond the United States.

Objective(s):

1. Describe identity across cultures and national boundaries as multifaceted and complex.
 2. Compare data on gender in a variety of cultures globally.
 3. Compare and contrast the impact of various cultural customs and traditions on women from different parts of the world, with emphasis on identity factors such as race, color, language, religion, national origin, gender, sexual orientation, age, and/or socio-economic status.
 4. Recognize ethical issues associated with ethnocentrism and American exceptionalism.
 5. Identify how gender is shaped by historic, economic, political, and/or social factors such as ethnocentrism, colonialism, slavery, democracy, and imperialism.
 6. Describe how both individual and cultural identities are shaped by nationality and ethnicity, as well as race, gender, sexuality, class, and/or disability
 7. Recognize ways in which international policies impact women's access to resources and how such policies are informed by cultural practices within historical, political, social, and economic systems.
 8. Discuss the meaning of empathy in the interpretation of personal and intercultural experiences.
