Women and Politics

#### **Catalog Description:**

This is an introductory course to the study of the United States' political process from a gender perspective. Specifically, the course looks at how gender impacts the political process in the United States and how women impact the political process at the federal, state, and local levels of government. Content includes addressing policy issues that may be of particular interest to women. Policy topics may vary and include reproductive rights, pay, employment, child care, and health care.

#### Course Outcome(s):

Demonstrate an understanding of how gender's role impacts women's participation in the United States' political process.

Civic Responsibility: Analyze the results of actions and inactions with the likely effects on the larger local and/or global communities.

#### Objective(s):

- 1. Explain how women engaged with and continue to engage with the United States' political process during the first, second, third, and fourth waves of feminism.
- 2. Discuss significant political achievements during the various feminist waves such as obtaining suffrage, civil rights achievements, and the #MeToo movement.
- 3. Explore women's efforts to gain representation in United States institutions through their voting behavior, interest group activity, engagement with political parties, and candidacy for political office.
- 4. Analyze mass media representation of women's participation in the United States' political process, notably the representation of women as candidates for political office.

#### Course Outcome(s):

Examine how gender's role influences the behavior of women who hold political office in the United States.

#### **Essential Learning Outcome Mapping:**

Civic Responsibility: Analyze the results of actions and inactions with the likely effects on the larger local and/or global communities.

#### Objective(s):

- 1. Explore women's involvement in all branches and levels of the United States government: within the legislative, executive, and judicial branches; and, at the federal, state, and local levels.
  - 2. Explore how women holding governmental positions impact the activities and operations of the United States government.
  - 3. Compare women's governing tactics with the governing tactics of men in similar positions.

#### Course Outcome(s):

Discuss how gender's role and women, as political actors, shape public policy in the United States.

#### **Essential Learning Outcome Mapping:**

Civic Responsibility. Analyze the results of actions and inactions with the likely effects on the larger local and/or global communities.

#### Objective(s):

- 1. Explain the nature of public policy and how it is made.
- 2. Explore the role of women in all phases of the public policymaking process in the United States.
- 3. Recognize the differences in policy preferences between men and women in the United States.
- 4. Analyze various policy issues. Topics can vary and may include family, reproductive rights, health care, education, social welfare, the workplace, sexual harassment, crime and punishment and economic equality.
